In 2024, the Fundação Francisco Manuel dos Santos doubled down on its commitment to creating and sharing knowledge by promoting debates and initiatives to contribute to a better-informed and more participatory society

Introduction

2024 SAW the Fundação Francisco Manuel dos Santos maintain its unswerving dedication to its mission of promoting knowledge and reflection about current realities in Portugal by orchestrating a series of projects and initiatives throughout the year. In January, the Foundation continued the "Five Decades of Democracy: What Has Changed?" programme, releasing four mini--documentaries aimed at young people documenting the changes in the country since the 25 April Carnation Revolution. The programme also featured an exhibition of Pordata infographics, which travelled to secondary schools across the length and breadth of Portugal and reached around 650,000 students.

In the field of science, the Foundation strengthened its internationalisation and impact strategy by commissioning new studies, policy papers and barometers. 2024's highlights include: the European Politics Barometer (edited by Ana Maria Belchior [ISCTE-IUL] and Lea Heyne [ICS-ULisboa]), which examined how Portuguese people relate to the European Union; the study *The Impact of Corporate* Tax on the Portuguese Economy (led by Pedro Brinca [Nova SBE]), which analysed how company profit taxes affect economic

growth; the Ageism in the Labour Market (edited by David Patient [Vlerick Business School]), which investigated generational tensions at work; The Corruption Barometer (edited by Luís de Sousa [ICS-ULisboa] and Susana Coroado [Dublin City University]), which measured Portuguese perceptions of corruption; and the Immigration Barometer: The Portuguese People's Perspective (edited by Rui Costa Lopes [ICS--ULisboa]), which examined opinions and attitudes on immigration.

Pordata, meanwhile, redesigned its technological and graphic structure this year by launching a new, interactive and accessible portal. The new portal boasts improved search functionalities, making searches more efficient. The content is now more up-to-date and in-depth, allowing users to cross-reference information more comprehensively. The layout has also been improved, with key indicators highlighted and interactive graphs and tables. The portal now even offers simulators where users can check the municipal property tax (IMI) rates for each civil parish and review the inflation adjustment of previous rates.

In terms of publishing, the Foundation published new books consistently throughout the year. One

highlight was the series "For Your Health - Physical Activity and Well-being," produced in partnership with the Faculty of Physical Education at the University of Lisbon. Another key publication was the end-of-year book Emblems of Portugal by Miguel Metelo de Seixas. At the Lisbon Book Fair, the Foundation achieved a significant sales increase due to its busy cultural programme over three weeks.

The Foundation also created some outstanding programmes throughout 2024. The podcast "[IN]Pertinent" continued bringing together new pairings of communicators and researchers to discuss the same areas: politics, society, science and economics. The politics discussions focused on political theory, while the society segments covered longevity, cognitive-behavioural psychology and criminality. Neuroscience was the topic of the science discussions, with the economics debates dealing with macroeconomics. The Foundation also produced online episodes and live broadcasts for the videocast "It's Not That Simple," which addressed topics such as migration (with Hein de Haas) and a changing planet (with Peter Frankopan). The partnership with RTP, meanwhile, yielded three co-produced documentaries: Long Live Democracy, Portugal in Europe and The Clean Energy Revolution.

In 2024, the Fundação Francisco Manuel dos Santos doubled down on its commitment to creating and sharing knowledge by promoting debates and initiatives to contribute to a better--informed and more participatory society. Furthermore, it also strengthened its focus on impact and internationalisation. The range of projects — from scientific studies and opinion barometers to documentaries, podcasts and the Pordata modernisation — demonstrated the

importance of the Foundation's work for examining and understanding contemporary Portuguese reality. With its unwavering dedication to innovation and impact, the Foundation continues to play a crucial role in supporting Portuguese society to respond to the challenges of the future by promoting critical reflection and disseminating robust data.

Social Bodies

THE FOUNDATION'S social bodies consist of the Board of Trustees, the Salaries Committee, the Board of Directors, the Supervisory Board and the Executive Committee, Each of these entities serves a vital function in achieving the Foundation's mission.

In 2024, both the Board of Trustees and the Board of Directors were reorganised with new compositions whose mandate extends through to 2027. Eduardo Marçal Grilo and D. Manuel Clemente left their posts as trustees, while Ricardo Reis joined the Board of Trustees, along with Maria Manuel Mota and Fátima Barros (who both transferred from the Board of Directors). Nuno Crato's mandate on the Board of Directors came to an end, with General Director Teresa Mourão-Ferreira joining the Board of Directors.

The Executive Committee held frequent weekly meetings throughout the year and kept the social bodies fully informed of the Foundation's activities. The Foundation also sent out a monthly newsletter to these bodies, as well as to the founding society. The newsletter clearly summarised monthly achievements and previewed next month's events and was accompanied by the monthly financial report prepared by José Quinta (Financial Advisor).

Since 2009, the Supervisory Board and the external auditor have been providing essential input to the Foundation to guarantee its full financial and accounting transparency.

The Foundation also maintained regular contact with the Presidency of the Council of Ministers. This body legally oversees the Portuguese foundation sector and ensures compliance with all approved legal standards.



Participation in the Portuguese **Foundation Centre**

IN 2024, the Fundação Francisco Manuel dos Santos played an active role in the Directorate of the Portuguese Foundation Centre (Direção do Centro Português de Fundações, CPF), led by Executive Director António Araújo. The Foundation conducted several national and international initiatives to defend and promote the Portuguese foundation sector, which received support from João Tiago Gaspar. At the end of the year, António Araújo was re-elected as a member of the CPF Directorate.

Operational Management

EXECUTIVE DIRECTOR Teresa Mourão--Ferreira led the operational team during 2024. As per established practice, day-to--day management was overseen by the Executive Committee, with contributions from its other members who lead the scientific, publications and Pordata departments.

The operational team was reorganised over the course of the year, in accordance with the new strategy and to reinforce its pillars of institutional assertion, impact, and internationalisation. João Tiago Gaspar took on the role of Head of Content and International Relations, while Carlos Jalali took on the responsibility of coordinating the studies team on a contractual basis, in addition to his role as institutional consultant.

Pordata's significant reorganisation involved splitting the team into two areas: technical and content. Inês Falcão vacated her position managing the statistical database, while Joana Mateus joined the team from January to August as Content Manager. External consultants also participated in preparing the new portal, including Ana Teodósio, Catarina Ruivo, Joana Mateus (from September to December), João Pinto (via Xpand IT), João Verdasca and Marta Miranda.

At the end of September, Mariana Vaz da Silva stepped in to head up marketing, innovation, audiovisual production and events following Teresa Pina's return to the Oceanário de Lisboa. Richard Freuis retired at the start of 2024. although Maria Eiró had been handling his responsibilities for the Foundation's own programming since late 2023.

Mariana Vaz was in charge of the press office and media partnership management until April, when Maria Ferreira took over these responsibilities via her own company's services.

The Foundation celebrated its 15th anniversary in 2024 and saw its spontaneous awareness increase significantly to 18%, up from 15% in 2023. The outcome was the result of concerted collaboration across the entire team to promote a vast range of projects. In 2024, the price for a media space dedicated to the Foundation's work (excluding joint projects) would have been about €258 million. This represents an AAV (automatic advertising value) 27% higher than in 2023. The Foundation's programming reached 67 million views, its highest levels ever and a 9% increase from the previous year. Partnership with the main national media also boosted audiences

by 21%, while the cost per contact fell to €0.09, 10% lower than in 2023.

The team worked across the three strategic pillars: impact and change, internationalisation and institutional assertion. In addition to studies, the Foundation also published policy papers and barometers, which allowed the Foundation to act more quickly and respond to Portugal's challenges with clear diagnoses and recommendations. The Foundation also held meetings with key stakeholders in each area. Furthermore, it made several international presentations and launched a three-year studies programme focused on international projects, as well as strengthening links and partnerships with European and Atlantic universities, foundations and think tanks.

The year's central theme was "Five Decades of Democracy." The Foundation released its first four mini-documentaries, aimed primarily at young people, documenting the changes that have taken place since 25 April. It also organised an exhibition of Pordata infographics on this theme, which travelled to secondary schools across the country and reached 650,000 students. The exhibition was later adapted into three-dimensional modules and shown at the Lisbon Book Fair, as well as several iconic venues in various cities.

Revamping Pordata's technological and graphic structure concluded with the launch of the new portal. This process faced several challenges, forcing the team to suspend Pordata's social media communications and reduce the number of press releases from eight in 2023 to six. Media coverage of Pordata reflected this shift, with only 2,589 articles on Pordata in 2024 (15% fewer than in 2023). This decrease, however, was partly offset by a smaller fall-off in AAV, which fell

by only 2% compared to the previous year. This reduced drop is the product of a 39% increase in articles published in high-reach media (1,260 in 2024 versus 905 in 2023). The old website remained active during the migration to the new portal to ensure users were still able to access data and functions.

The Foundation also worked to deepen public understanding of Portuguese reality through its publications, constantly seeking to improve editorial efficiency. To reach new audiences, it launched a series on motricity and well-being that followed an earlier series on nutrition in 2023. Although sales of the new series did not match last year's figures, total publication sales in 2024 — including essays, portraits and other books - exceeded those of 2023, with 88,153 copies sold (+2%) and a total value of €266,184 (+27%).

The Foundation team worked tirelessly throughout to attain its objectives: strengthening civil society and defending democracy through knowledge, open dialogue and active citizenship.

The Foundation continued its 2023 strategy on digital output, producing content and formats specifically for its audiences on each channel. Followers increased by 40% on Instagram, 30% on LinkedIn, 16% on YouTube, 6% on X and 1% on Facebook. By the end of 2024, 469,000 people regularly followed the Foundation's channels (+11% from 2023). The team continuously measured results and implemented improvements.

Regarding traffic to the Foundation's website, sessions increased by 17%, unique users by 13% and average visit time by 8% compared to 2023. The most visited pages were "Rights and Duties," "Bookshop," "FFMS Play" and "Atual_mentes" ("Current_minds"). The podcast "[IN]Pertinent" reached a total audience of 575,000 (33% higher than in 2023). The programme "It's Not That Simple" was seen by 1 million people (19% lower than in 2023), and its podcast was listened to by 15,000 people (a 60% increase from 2023). It produced 12 episodes, three of which - featuring historian Peter Frankopan, researcher Hein de Haas and General David Petraeus - were recorded live in front of an audience. The Foundation Square series of debates reached 409,000 people (3% lower than 2023). The session dedicated to the book Emblems of Portugal achieved the highest online audience ever, with 62,000 views.

In 2024, 60 students aged 15 to 17 from 17 of the 20 main regions of the country took part in the 6th Foundation Summer School. Only the Azores, Bragança and Vila Real regions did not send representatives. Over one week, the sessions focused on global geopolitics, featuring reflections and debates with national experts. The programme was prepared by Lívia Franco and speakers included Ana Santos Pinto, Bruno Cardoso Reis, José Maria Pimentel, Raquel Vaz-Pinto and others.

This year was marked by a strong partnership in programming. For example, RTP and RTP Internacional broadcast three co-produced documentaries, a series of pieces on "Five Decades of Democracy" on RTP's News and the mini--documentaries. SIC Notícias aired ten episodes of the programme "Facts That Count," along with debates and pieces

promoting the Foundation's barometers, both on SIC and in Expresso. CNN Portugal showed the series "How Do We Fix This?" and TVI aired interviews on related topics in the mornings. On CMTV's "Talking Globally," they showed Pordata portraits and interviewed Foundation authors. Rádio Renascença featured the programme "Cover to Cover" and the segments "The Foundation Suggests" and "The Foundation Gives Food for Thought." Rádio Comercial covered and explored the themes of the mini-documentaries. The newspaper Público published the article series "What Do Portuguese People Worry about?" Visão magazine ran a special on physical activity and well-being. Jornal Económico and Jornal de Negócios published opinion pieces. Finally, the videocast Bom Partido covered the European elections.

The Foundation team worked tirelessly throughout to attain its objectives: strengthening civil society and defending democracy through knowledge, open dialogue and active citizenship.



IN MID-2024, the Foundation's research area underwent a major restructuring. Internationalisation became a strategic priority, and many of the institution's outputs began to move beyond traditional research projects (such as studies, policy papers, and barometers) designed directly for a wide range of audiovisual formats (TV and radio programmes, documentaries, podcasts, videocasts, etc.). Additionally, former Head of

Research and Science Communication, João Tiago Gaspar, was promoted to Director of Content and International Relations, while Carlos Jalali, former scientific adviser on democratic quality, stepped in as Head of Research and Science Communication and also took charge of coordinating the Foundation's research team.


This change was intended to free up more time and resources for producing and disseminating content specifically aimed at mass-media audiences — a task now managed by João Tiago Gaspar — while still ensuring the production of rigorous scientific projects (such as interdisciplinary studies and policy papers developed in partnership with leading international institutions), a responsibility now handled by Carlos Jalali.

Both continue reporting directly to the Chairman of the Board, Gonçalo Saraiva Matias, who retains overall responsibility for the Foundation's content and research. They also jointly supervise the work of Clara Bento (in charge of project management and science communication for economic development), Inês Renda (project management and science communication for democratic quality), and Rita Rosado (project management and science communication for social policies)


In 2024, the Foundation publicly launched its new research programme, which will run until the end of 2026. This programme focuses on three main areas: economic development; social policies for combating poverty and inequality; and democratic quality. The scientific consultant for the first area is Miguel Ferreira (Nova SBE), the second Amílcar Moreira (ISEG-ULisboa) and the third Carlos Jalali, who — as mentioned earlier — also coordinates the research team.

This year also saw the Foundation commission two studies, one policy paper and three barometers. They are as follows:

"Eupinions", a study on perceptions of European politics commissioned by the Bertelsmann Foundation:

"Taxation and the Future", a multidisciplinary study edited by Sérgio Vasques (Faculty of Law, Universidade Católica Portuguesa) in partnership with the University of Vienna and the Tax Foundation;

Policy paper "The Impact of Business Training and Mentoring on Firm Performance: An Experimental Approach", edited by Miguel Ferreira (Nova SBE);

"Local Power Barometer", edited by Filipe Teles and Nuno Ferreira da Cruz (University of Aveiro);

"Tourism Barometer", edited by Eduardo Brito Henriques (IGOT-ULisboa); and

"Immigration Barometer: The Immigrant Population's Perspective", edited by Rui Costa Lopes (ICS-ULisboa), Pedro Góis (University of Coimbra), and João António (CESOP-Católica).

2024 marked a turning point for the Foundation in terms of both reach and impact. On the media front, four new audiovisual formats were launched with unprecedented results:

- 1. "Facts That Count", a weekly data dissemination programme presented by the Foundation's chairman during prime time on SICN:
- 2. "How Do We Fix This?", an interview show with Foundation authors broadcast by CNN that spawned a spin-off on TVI's most--watched daytime programme, Dois às 10;

- 3. A series of eight minidocumentaries on "Five Decades of Portuguese Democracy," aimed at young audiences and shown on YouTube and RTP (with the first four already broadcast); and
- **4. "Plenary Session"**, a segment on the programme Bom Partido, developed by comedian Guilherme Geirinhas, which provided information on European politics ahead of the European Parliament elections.

In terms of impact, various sovereign bodies and public organisations consulted with the Foundation frequently throughout 2024. It was asked to contribute proposals for reforms in key areas — such as corruption, housing, taxation and the competitiveness of the European economy — all based on insights from its scientific studies and other publications.

I. Scientific Projects Published in 2024



1. European Politics Barometer

Editors: Ana Maria Belchior (ISCTE-IUL) and Lea Heyne (ICS-ULisboa) **Publication Date**: May 2024

Summary: Nearly four decades after joining the European bloc, the Foundation's second barometer examines the relationship between Portuguese citizens and the European Union. The results show that people have greater trust in and a

more positive perception of European institutions than of national institutions. Most respondents (85%) feel represented, believing that voting in EU elections allows them to express their views. However, the survey also highlights high levels of dissatisfaction with how member states are tackling issues like poverty, inequality, the Israeli-Palestinian conflict and immigration from non-EU countries. Almost half (45%) are open to allowing countries to join the EU, and among these, 58% view Ukraine as a strong candidate. Finally, 80% of citizens believe the EU should have the power to expel members who violate democratic principles, with Hungary singled out as an offender.



2. The Impact of Corporate Income Tax on the Portuguese Economy (Study)

Editor: Pedro Brinca (Nova SBE) **Publication Date: May 2024**

Summary: Have corporate profit taxes hampered national economic growth? What would happen if the corporate tax rate were lowered? And what are the consequences of legislative instability in corporate taxation, given that the corporate tax has been changed over 1,350 times since its inception in 1989? This study from economist Pedro Brinca (Nova SBE) offers answers to these questions and more.



3. Understanding Ageism in the Workplace (Study)

Editor: David Patient (Vlerick Business School)

Publication Date: August 2024 Summary: An ageing society and workforce bring both challenges and opportunities. The presence of multiple generations can create age-related tensions, with some workers viewed as "too young" and others as "too old." How these different groups interact affects workplace relationships, attitudes, performance, and employee well-being. Based on qualitative and quantitative surveys - including a representative sample of 1,000 Portuguese workers — this study finds that ageism has significant, mostly negative effects on both its targets and its proponents. The authors propose measures to reduce bidirectional ageism at work.



4. Corruption Barometer

Editors: Luís de Sousa (ICS-ULisboa) and Susana Coroado (Dublin City University) Publication Date: September 2024 **Summary**: The third barometer focuses on corruption, aiming to ascertain Portuguese citizens' knowledge and

feelings on this issue. Understanding societal and cultural attitudes toward corruption is essential both for assessing the ethical climate of Portuguese institutions and for devising more effective anti--corruption policies. The survey revealed that 90% of respondents view corruption as one of the country's most serious problems, and half feel personally affected by it. Most consider the fight against corruption ineffective, and many believe that politics attracts those seeking personal gain over the common good and has the potential to corrupt honest individuals. In general, respondents see all political systems — democracies, technocracies and autocracies — as equally vulnerable, with football and political institutions identified as especially susceptible.



5. Immigration: The Portuguese People's Perspective

Publication Date: December 2024
Summary: The fourth barometer examines immigration, seeking to understand how Portuguese residents view immigrants and the social and economic impact of immigration. In the context of markedly accelerated immigration to Portugal since 2015, the results offer a comprehensive and detailed insight into public opinion and attitudes, thereby informing public debate and supporting the formulation of policies to promote social coexistence and integration amid social and economic development.


Publications

SUSANA NORTON remained responsible for coordinating the publications department under António Araújo's direction and with external support from Duarte Vaz-Pinto.

The Foundation's publications became more successful and impactful in 2024 — this was particularly evident in the high turnout of young people and a sales increase of about 40% in value and 29% in volume at the Lisbon Book Fair. This impressive result was largely driven by an intensive three-week cultural programme that featured 14 debates on the Foundation's publications, a live show and two "live on tape" episodes in collaboration with Rádio Renascença, the latest iteration of a long-standing partnership with the station.


As in previous years, the Foundation also maintained a strong presence at the Book Festival in Belém —an institutionally significant event organised by the Presidency of the Republic. Additionally, the Foundation continued its partnership with El Corte Inglés and FNAC in Lisbon and Porto, hosting numerous book presentations that consistently drew large audiences.

In an effort to decentralise its activities and in-person events, the Foundation also hosted a debate on corruption at the



All FFMS book presentations were recorded and broadcast on the Foundation's YouTube channel to stimulate wider discussion of the themes addressed. 

The Foundation continued investing in making its publications available in digital formats, disseminating its content online, launching new titles as ebooks, and selling titles through online channels. Meanwhile, FFMS maintained its presence in traditional outlets, with sales volumes higher than in the previous year.

FFMS also ensured the regular and timely release of all scheduled titles. The following titles were published as part of the "Foundation's Essays" series:

As part of its internationalisation efforts, the Foundation also began selling its publications at La Petite Portugaise bookstore in Brussels.

Pordata

EXECUTIVE DIRECTOR Luísa Loura managed Pordata throughout 2024. Ana Luísa Barbosa, meanwhile, was responsible for coordinating the team, which consisted of Joana Zózimo, Mónica Santos, Sofia Barão, Inês Falção (until March), Joana Mateus (until August), Felippe Clemente, and Andreia Marçal.

2024 marked a major "house move" for Pordata. In 2023, the groundwork was laid, a new portal was built and the logistical system for migrating the data archive was developed. Yet this transition was more than just a platform change: it innovated navigation, content and information delivery.

Navigation was streamlined, prioritising search efficiency. Content became more up-to-date and detailed, allowing for more precise cross-referencing. Data presentation was also improved: key indicators are now highlighted, and charts and tables became more interactive.

By the end of 2024, after meticulous technical work to migrate data, integrate the government-mandated changes to the organisation of Portuguese territorial units (Nomenclature of Territorial Units for Statistics, NUTS) and update the National Accounts, over 13 million data points were made publicly available on 457 panels, each typically comprising three visual elements: a time-series graph showing the indicator's evolution in Portugal, a bar chart comparing EU countries and a map illustrating the territorial distribution across Portugal's 308 municipalities. Among the 22 topics covered, the most prominent were population, migration, poverty, environment, agriculture, health, business, employment and the economy.

















The new Pordata portal also introduced a simulators section, allowing users to check the Municipal Property Tax (IMI) by civil parish and to view previous inflation adjustments.

2024 also saw the infographic series "Five Decades of Democracy" achieve its widest visibility. This series, with easy-to-read visuals, traces the country's evolution from the 1970s to the present, covering themes such as families, population, schools, higher education, transport and work.

In partnership with the School Libraries Network, Pordata organised an exhibition that toured 448 public school groups and reached about 650,000 students. The inaugural event took place on 18 April 2024 at Camões Secondary School in Lisbon and included a debate on 50 years of educational change featuring experts Mónica Vieira and Pedro Freitas and moderated by Hugo van der Ding.

The exhibition was also adapted for high-traffic public spaces, being displayed at the Ciência Viva Pavilion in central Olhão, at the University of Algarve, at the University of Évora, as well as in Lisbon at Campo Grande and in the Amoreiras district.

Additionally, journalist Alberta Marques Fernandes developed and presented a series of ten one-minute videos on RTP1 based on the infographic series. This series offered the general public a concise and impactful view of the country's transformations over the past five decades.

From Data to Information

In line with the Foundation's mission. transforming data into useful information remains a top priority for Pordata. On commemorative days or during major national and international events, the Foundation prepared and distributed five thematic summaries to the media. These summaries generated 1,186 news articles - accounting for 46% of all Pordata--related news. The summaries, along with their synopses, are as follows:

10 March 2024: Legislative Elections in Portugal

A dataset tracking the evolution of legislative elections in Portugal - from 25 April 1974 to the latest elections in 2022 - accompanied by indicators reflecting the Portuguese public's perceptions of national politics.

25 April 2024: 50 Years of Democracy in Numbers

An infographic comparing Portugal in 1974 with its situation after five decades of democracy, highlighting progress and ongoing challenges. Based on 28 infographics by Ricardo Garcia and Ana Serra, it illustrates profound changes in demography, population and family profiles, transport modernisation, access to health and education, labour market achievements and social protection, as well as living conditions in the country.

1 May 2024: Labour Day

A portrait celebrating Labour Day, with indicators that characterise the profile of the employed population in Portugal in comparison with the European Union. The analysis covers age, education levels, salaries and types of contracts.







11 July 2024: Population Day

Data presenting the current profile of Portugal's resident population, including population size, trends in family structures, Portugal's standing within the EU and the age distribution.

17 October 2024: International Day for the Eradication of Poverty

A portrait of poverty in Portugal, one of the most urgent challenges facing the country. The portrait focused on data on poverty and its fluctuation, but also on other issues that directly influence it, such as the price of housing relative to wages in Portugal. Furthermore, it included an analysis of Portugal's position in the European context.

Communication and Foundation **Events**

Conferences, Debates and Other Events

IN 2024, the Foundation continued its own programming under the theme "Five Decades of Democracy: What Has Changed?", a project launched in 2023 to raise awareness of the country's development over the past five decades. In March, ahead of the 50th anniversary of the Carnation Revolution of 25 April 1974, the Foundation launched a mini--documentary series titled "And After the Revolution?" The first season, comprising four episodes of about 20 minutes each, covered the following topics:

- Democracy: What Kind of Democracy Did We Build?
- Gender Equality: What Have Women Achieved?
- Population: *Are There More or Fewer of Us?*
- Economy: *How Has the Economy Evolved?*

Targeted primarily at young audiences, this series marked the Foundation's debut in independent documentary production. It was released on YouTube and heavily promoted on Instagram, its target audience's preferred platform. To maximise reach, the Foundation implemented a promotional campaign through influencers and established a partnership with Rádio Comercial, whose demographic aligns with the series' audience. On 19 June, at Cinema São Jorge in Lisbon, the Foundation held the first of four live events centred on the mini-documentary series, featuring a debate on democracy and gender equality with speakers Maria Castello Branco, Mariana Esteves and

Guilherme Geirinhas, which over 150 people attended.

Also continuing the "Five Decades of Democracy: What Has Changed?" theme, Pordata partnered with the School Libraries Network to create an exhibition of 22 infographics, which toured 448 school groupings and reached over 650,000 students nationwide. On 18 April, at Luís de Camões Secondary School in Lisbon, over 200 people attended a debate to mark the official launch of the exhibition featuring Pedro Freitas, Mónica Vieira and Hugo van der Ding.

Live events were also held at El Corte Inglés, where six essays and six portraits were presented in debates with authors and experts, with active audience participation. These sessions were later made available on the Foundation's YouTube channel. Additionally, the book Emblems of Portugal by Miguel Metelo de Seixas was presented at the Carmo Archaeological Museum Auditorium.

The Foundation participated in the 94th Lisbon Book Fair (29 May—16 June) by launching six essays, six portraits, and the "For Your Health — Physical Activity and Well-Being" motricity collection in live debates at the Foundation Square, in addition to three programmes produced in partnership with Rádio Renascença.

On 6 June, at the Oceanário de Lisboa, the Foundation presented its research programme for the 2024-2026 triennium to around 200 researchers. both in person and via live stream. In his opening remarks, Gonçalo Saraiva Matias highlighted the new features of the programme, which include both studies and policy papers, with an emphasis on multidisciplinary, international projects with significant societal impact. Three scientific consultants — Carlos Jalali, Amílcar Moreira and Miguel Ferreira outlined the three thematic lines of the new triennium: economic development, social policies to combat poverty and inequality and democratic quality.

On 18 October, this same research programme was presented at an exclusive event with public and private stakeholders. The session discussed strategies to enhance the competitiveness of the Portuguese economy and incorporated feedback from diverse participants (intentionally drawn from individuals under 50) to inform future studies and initiatives. Speakers included State Minister for Finance Joaquim Miranda Sarmento, Minister of the Presidency António Leitão Amaro, Socialist MP Mariana Vieira da Silva, Rui Miguel Nabeiro (CEO of Delta Cafés), Amélia Santos (CEO of Innuos), José Pimenta da Gama (managing partner at McKinsey Iberia) and Sofia Tenreiro (partner at Deloitte Portugal).

The studies *The Impact of Corporate* Tax on the Portuguese Economy and Understanding Ageism in the Workplace were presented via infographic videos, a communication format introduced in 2023 to make study findings more accessible. The first study, led by Pedro Brinca, also served as the focus of a stakeholder meeting on 8 July at the Belém Cultural Centre. Chaired by Gonçalo Saraiva Matias and attended by Economy Minister Pedro Reis, State Secretary for Fiscal Affairs Cláudia Reis Duarte, Director-General of the Tax and Customs Authority Helena Borges, alongside representatives from business confederations, trade unions, and independent bodies, such as the Public Finances Council (Conselho das Finanças Públicas, CFP) and the Budget Support Technical Unit (*Unidade Técnica de Apoio* Orçamental, UTAO), the session addressed this vital topic for national development and cohesion.

At the international level, the Foundation hosted three distinct events in Brussels:

On 31 January, at the La Petite Portugaise bookstore, the Foundation presented the book Crises in the Portuguese Economy, 1910-2022 to an audience of around 35 people. The event featured a debate between Ricardo Reis (Chairman of the Economic Crises Committee at FFMS and a professor at the London School of Economics) and Cristina Sofia Dias (Deputy Head of Unit at the European Commission's DG REFORM), moderated by Susana Frexes, a correspondent for SIC and Expresso in Brussels. This was followed by a dinner attended by

MEPs and key Portuguese representatives in European institutions.

On 10 September, at the Concert Noble, over 140 guests attended the screening of the documentary *Portugal in Europe,* co-produced with RTP. Gonçalo Saraiva Matias hosted the event, followed by remarks from Ambassador Pedro Costa Pereira (Portugal's Permanent Representative to the EU) and closing remarks by State Secretary for European Affairs Inês Domingos, before a cocktail reception. Participants included European Commissioner Elisa Ferreira and Ambassador Ana Paula Moreira, as well as MEPs and other European institution representatives.

At the third event in Brussels, on 11 December, the Foundation continued its international outreach by meeting with a group of MEPs to discuss the study "Mechanisms and Impacts of Electoral Abstention in Portugal," edited by João Cancela (Nova FCSH) and José Santana Pereira (ISCTE-IUL) and due for publication in 2025. This meeting aimed to obtain valuable input from elected representatives on the causes and best strategies for combating abstention in the European elections, as well as to publicise the preliminary results of the research. The session was organised in collaboration with the offices of MPs Marta Temido (Socialist Party, PS/Progressive Alliance of Socialists and Democrats, S&D) and Paulo Cunha (Democratic Alliance, AD/EPP), the heads of mission of the two largest parties represented. Also present were MPs Paulo Nascimento Cabral (Democratic Alliance, AD), Sérgio Humberto (Democratic Alliance, AD/EPP), Hélder Sousa Silva (Democratic Alliance, AD/EPP), João Oliveira (Portuguese











Communist Party, PCP/The Left) and Ana Vasconcelos (Liberal Initiative, IL/Renew).

The Summer School, held in Peniche from 1—8 September and with geopolitics as its main theme, welcomed 60 students aged 15-17 from various regions, including the Autonomous Region of Madeira. The programme featured lectures, expert-led working sessions, Oxford-style debates and a Model UN simulation. Furthermore, there was also a World Café session with six speakers from diverse backgrounds in diplomacy, journalism and politics. Topics included the war in Ukraine, Russia—EU relations, the Israeli-Palestinian conflict, tensions in the Middle East and the impact of the US presidential elections, with Bruno Cardoso Reis among the speakers. Recreational activities included a boat trip to the Berlengas archipelago and a tour of Peniche, Lívia Franco from the


Universidade Católica served as scientific consultant for the project.

The Foundation continued producing digital content with its series of international expert interviews on key current topics in the programme "It's Not That Simple." Guests included Roberta Metsola (who hosted a live interview on youth and politics at the end of 2023), Lisa Damour (on adolescence), Esther Duflo (on poverty), Anu Bradford (on the "Brussels Effect"), David Petraeus (on war and peace), Ashton Applewhite (on ageism), Uma Naidoo (on food and the brain), Harry Enten (on US elections), Colin Bryar (on e-commerce) and Peter Apps (on the future of NATO).

The Foundation recorded two live episodes as part of this series: one with migration expert Hein de Haas on 18 April at the Faculty of Dental Medicine Auditorium in Lisbon (with around 280













participants) and another with acclaimed author Peter Frankopan on 17 June at the Capitólio in Lisbon (with about 320 attendees). These live events, which began in 2023, continued throughout 2024 to generate deeper engagement among the Foundation's audience.

The podcast "[IN]Pertinent," aimed at a younger audience, maintained its core concept — a lively exchange which balances curiosity and knowledge. In 2024, the podcast teams were as follows: on economics, presenters Inês Castel-Branco (later joined by Mariana Alvim) discussed macroeconomics with José Alberto Ferreira; on science, Rui Maria Pêgo and Luísa Lopes delved into neuroscience; on politics, Manuel Cardoso and João Pereira Coutinho analysed current issues through the lens of political theory; on society, Hugo van der Ding interviewed three specialists — Sibila

Marques (on longevity), Ana Moniz (on well-being and mental health), and Isabel Rocha Pinto (on security and crime) — each contributing four episodes. These episodes were promoted through video teasers on social media, in collaboration with communicators, which resulted in a 61% growth in Spotify followers, a 54% increase on Apple Podcasts and an overall audience increase of 33% from 2023 (with the society segment growing by 84%).

Throughout 2024, the Foundation worked to expand its reach and connect with a broader, more diverse audience by offering a range of formats and content to strengthen its relationship with society and foster debate on the issues addressed.













Awareness of the Foundation

In 2024, the Fundação Francisco Manuel dos Santos was the foundation with the third highest level of spontaneous awareness. Previously, it vied for third place with Fundação Mário Soares, but now appears to have consolidated its position just behind Fundação Gulbenkian and Fundação Champalimaud, showing a three-percentage-point increase compared to 2023. Nearly four out of five respondents (79%) recognised the Foundation or one of its projects, and 89% considered its impact on society to be significant or very significant, both up 2% from 2023.

The Foundation's most spontaneously recognisable projects are still Pordata, its research studies and its publications. Similarly to the previous year — and following three years of sustained work on both communication and format and content adaptation — the Foundation's awareness increased by 1% in the 18-24 age group, 1% in the 25-34 age group and 5% in the 35-44 age group.

Through its range of publications, programmes and initiatives, the Foundation remains committed to promoting knowledge of key areas of Portuguese reality (politics, economy and society) and empowering citizens to form informed opinions, engage in relevant debates, move from passive to active citizenship, strengthen their rights and contribute to improving the institutions that serve them.

Digital Area

THE FOUNDATION'S website continued to attract and retain visitors throughout 2024. Users began 1.9 million sessions - up 17% on 2023 - and the number of unique users rose by 13% to 1.4 million.

This growth reflects the improvements made to our navigation and information architecture. Interaction quality also improved: the engagement rate per user rose by 13% and interactive sessions increased by 14% compared with the previous year. In other words, the Foundation not only reached new audiences but also kept them engaged.

We introduced new ways of presenting information, including a policy paper in partnership with Brookings and three interactive barometers — European Politics, Corruption and Immigration. Furthermore, we updated the "Born in Portugal" and "Unequal Portugal" projects with new graphics, data and text, adding deeper analysis and fresh content.

We also continued publishing monthly updates to the "Rights and Duties" project. It remains the site's most visited section and will receive further navigation improvements in 2025.

The Foundation's online bookshop was the site's second most visited section, with over 245,000 sessions. It was followed by the "Atual_mentes" ("Current_ minds") section, which climbed one place in visitor preferences to record 222,760 sessions — an 11% increase on 2023.

Our weekly newsletter also drove a high volume of traffic to the site. In 2024, subscriptions reached 34,000 - up 8% on the previous year — despite removing long-inactive addresses (over three years



Overall, 66.8% of visits came via mobile devices (up 14% from 2023), followed by desktop (31.6%) and tablets (1.6%). Visits from smart TVs remain negligible.

The Foundation on Social Media

Our digital strategy of tailoring Foundation content to each platform continued gaining us new followers in 2024. Additionally, engagement and retention rates grew thanks to targeted investment and new formats in accordance with trends on specific platforms.

The Foundation's social media community grew by 11% to over 469,000 followers, driven largely by younger, more dynamic platforms such as Instagram, YouTube and LinkedIn. Compared with the previous year, overall engagement rates, which measure a wide range of engagement versus reach metrics, rose on all networks except Instagram, where they fell by 4.2% compared with 2023.

Facebook — our largest network and the most effective for book-sales advertising – also presented growth of 2.5%, bucking the declining global trend for that platform.

In 2024, social media played a crucial role in promoting new and existing website content to a younger, more diverse and highly educated audience. It also proved vital in broadcasting data from studies, books and Foundation authors, generating increased media coverage.

In 2025, the Foundation's communication strategy may include joining new social networks. To that end, we initiated a SWOT analysis in 2024 focused on TikTok. This year, the Foundation has started developing an entry strategy for that platform, creating experimental content formats that are currently being refined for later evaluation.

The Foundation and the Media

Press Office

DURING 2024, which marked its 15th anniversary, the Foundation adopted a new strategic focus on impact rather than sheer reach. This shift underscores our commitment to driving concrete societal change through scientific analysis and informed debate, actively contributing to public policy.

Despite this new priority, 2024 saw the Foundation achieve the highest number of news items and the greatest AAV in its history. This success evidences the media's recognition of our rigour and excellence, highlighting both the relevance of our themes and the trust journalists place in our content and analysis.

Our press office played a key role by ensuring our communications were strategic, targeted and aligned with media and social interests. Throughout the year, we privileged in-depth approaches that prompted reflection and influenced the public agenda, strengthening the Foundation's impact on national debate.

In 2024, we issued 5,088 news items, of which 2,615 (51%) appeared in high-reach outlets. These generated a combined AAV of €258 million. On television alone, our programming was viewed 50 million times.

Compared with 2023, total news coverage rose by 5% and AAV by nearly 30%. This growth was driven largely by the launch of new studies and references to earlier research, which doubled the AAV in that area.

Among the Foundation's Studies, the *Immigration Barometer* made a particularly strong media impact, appearing in 495 news items — 75% in high-reach outlets — and achieving an AAV of over €28 million, with coverage lasting weeks after its public launch.

The Impact of Corporate Tax on the Portuguese Economy was the second most cited study, with 255 news items and an AAV of €20 million. The Foundation revived the pre-publication briefing format to promote this study, holding private sessions between its authors and specialist journalists. This was a crucial measure, especially given the topic's centrality in contemporary political debate, and allowed journalists to question the authors directly, clarify doubts and deepen their understanding, resulting in more rigorous, contextualised and informed coverage.

This was followed by the European Politics Barometer, presented on Europe Day ahead of the European elections, which generated 107 news items and an AAV of €10 million. Next came the Corruption Barometer, which produced 133 news items and an AAV of €2.5 million.

Finally, the Ageism in the Workplace study — launched in August on World Youth Day — resulted in 167 news items and an AAV of €2 million. The first policy paper on Europe's energy transition, produced with Brookings Institution, generated 51 news items and an AAV of €500,000.

Six press releases were released on Pordata. The most cited was on the Legislative Elections (late February), generating over 200 items and an AAV of €9 million. This was followed by the 25 April release (202 items, €20 million AAV) and the Labour Day release (166 items, €27 million AAV). The Population Day release in July saw 330 items and €11 million AAV, while the Poverty Eradication Day release in October generated 275 items and €7 million AAV.

The Foundation's publications earned 367 news items (20% on television) and generated an AAV of €15.3 million. The titles which received the greatest media attention were three Portraits — Unfinished Revolution: What didn't change with 25 April, An Ink-Smudged Finger: Stories of People Who Couldn't Learn to and The Library — along with the essay How the Portuguese Sleep. Over 60% of news coverage for Foundation publications appeared in high-reach outlets.


Media Partnerships

The Foundation forged various content partnerships during 2024, including print media, all national general-interest and news TV channels and several of the highest-audience radio stations. This milestone underscores the media's recognition of the rigour and excellence in our studies, publications and projects, reinforcing the Foundation's unique position.

Partnerships varied in content. Some required bespoke editions, such as the documentaries and the weekly programme "Facts That Count," while others arose from fresh analysis of earlier studies, like the

Público series "What Do Portuguese People Worry About?" or the CNN interview series "How Do We Fix This?"

Regarding television, the Foundation collaborated with RTP1 and RTP3, TVI and CNN, SIC and SIC Notícias and CMTV, as well as signing a deal with the new NOW channel (programmes to air in 2025).

The Foundation contributed regular articles and in-depth analyses to the print media outlets Expresso, Público, Jornal de Negócios, Visão and Jornal Económico. Additionally, it also formalised a partnership with the magazine Domingo from the Correio da Manhã, with publications planned for 2025.

On radio, the Foundation maintained weekly programmes on Rádio Renascença and made appearances on Rádio Comercial. We also secured a deal to air the "Talking Globally" series —dedicated to the Foundation's books, with interviews of their authors — on Correio da Manhã Rádio in 2025.

Below is a summary of key partnerships by outlet:

RTP

We co-produced three documentaries with RTP1: Long Live Democracy in March (1.3 million viewers), Portugal in Europe: Roots and Horizons in May during the European elections (815,000 viewers), and The Clean Energy Revolution in November (1.3 million viewers).

The first four mini-documentaries in the "And After the Revolution?" series - covering economy, democracy, population and gender equality - aired on RTP1, RTP3, RTP Internacional and RTP Play, reaching 800,000 viewers.

From May to June, a prime-time series of ten programmes based on Pordata infographics also aired as part of the "Five Decades of Democracy" project, attracting nearly 3 million viewers.

CMTV

Following 2023's success, CMTV broadcast ten episodes of "Talking Globally," featuring in-depth interviews with Foundation authors, alongside 44 weekly Pordata Portrait segments (290 broadcasts in total). In 2024, these one-minute Pordata segments focused on comparative analysis between Portugal and other European countries to provide its audience with information during a year of European elections. These programmes reached 18 million viewers, a 15% increase on 2023.

EXPRESSO, SIC AND SIC NOTÍCIAS

Building on the partnership with SIC Notícias e *Expresso*, the Foundation launched a new series to promote its three barometers: European Politics





Barometer (May), Corruption Barometer (September) and Immigration Barometer (December). These appeared on SIC's Jornal da Noite, in debates on SIC Notícias, as articles on SIC Online and Expresso Online and as major print features in the Expresso newspaper. The Foundation published 30 articles as part of this partnership, generating around €4 million AAV and reaching 4.2 million TV viewers.

On SIC Notícias, our weekly "Facts That Count" segment aired ten prime-time editions on the programme Grande Edição. This innovative format presents objective data on Portugal's main challenges through rigorous graphics, offering an empirically well-founded approach as opposed to a more traditional opinion model. Topics included housing, poverty, migration, education, health, economic productivity, demography, environment, gender equality, democratic quality and corruption, delivering a comprehensive and enlightening portrait of the current Portuguese context.

The programmes drew 800,000 viewers and generated €1.2 million AAV.

TVI and CNN

We created "How Do We Fix This?", a new interview series exploring Portugal's most pressing challenges and some potential solutions. In eight weekly 15-minute

episodes, CNN's editorial deputy director Raquel Matos-Cruz interviewed experts, who presented concrete recommendations for hotly debated topics which defy simple explanation. Topics and guests included: infrastructure and transport with Carlos Oliveira Cruz; housing with Pedro Brinca; the Portuguese economy and productivity with Ricardo Reis; SME financing with Cláudia Custódio; health system and access to the National Health System (Serviço Nacional de Saúde, SNS) with Pedro Pita Barros; immigration with Pedro Góis; population ageing with Alda Azevedo: and talent retention and skilled emigration with Pedro Freitas. Three further episodes will air in January 2025.

Additionally, a daily "CNN Minute" distilled one key idea from each author. We also published online dossiers combining the experts' opinions, data and recommendations with strong infographic elements.

After the CNN broadcasts, authors appeared on TVI's Dois às 10 with Cristina Ferreira, offering a less technical, more accessible discussion aimed at a broader and more diverse audience.

In 2024 alone (the project ran into January 2025), these broadcasts attracted nearly 2 million viewers and €1 million AAV.

Rádio Renascença

The Foundation maintained the existing partnership, airing the programme Cover to Cover on Tuesdays at 23:15 and the segments "The Foundation Gives Food for Thought" on Tuesdays at 19:15 and "The Foundation Suggests" on Saturdays at 08:00.

In 2024, these programmes reached over 10 million listeners — a 104% increase on 2023 - more than doubling our audience.

Rádio Comercial

The Foundation formed a new partnership in April to promote the first season of our "And After the Revolution?" mini-documentaries. These 20-minute films for young audiences reflect on Portugal's evolution over 50 years of democracy in the country.

Rádio Comercial, with its young listenership, proved the ideal platform for this output, which featured segments on Manhãs da Comercial, videos of interviews with children on "It's Up To You," posts on the station's social channels, and both on-air and digital advertising.

Público

Our partnership with *Público* produced the editorial series "What Do Portuguese People Worry About?" This series comprised six fortnightly articles (June-August) based on earlier studies, barometers and policy papers: Poverty in Portugal: Trajectories and Daily Life; Transport Systems in Portugal; The Housing Crisis in Big Cities and Housing Barometer; Interest Groups in Portugal; Gender Equality; How We Eat What We Eat. Each article combined infographics with expert interviews to contextualise data and stimulate debate during a period of government transition. The series generated €400,000 AAV.

Jornal de Negócios

Our fortnightly "Awareness of the Facts" opinion pieces from the Foundation's chairman analysed key public-debate topics aligned with our communications plan. Each instalment addressed a theme such as European politics, corruption, poverty, skilled emigration, immigration and talent retention. With clear, evidence-based arguments, these articles fostered reflection on themes addressed in our published projects.

Jornal Económico

The Foundation published 12 monthly articles in print and online, written by authors of our Essays and Portraits series. In 2024, this partnership generated €131,000 AAV (up 5% on 2023).

Visão magazine

Our partnership with Visão vielded five articles on the impact of physical activity, exercise and sport on lifelong health and development. Published fortnightly over the summer, these pieces analysed the five books in the "For Your Health - Physical Activity and Well-being" collection, including infographics and interviews with authors and other experts. The series reached 342,000 readers and generated € 225,000 AAV.

ECO

The study "The Impact of Corporate Tax on the Portuguese Economy" was presented and debated in an event aimed at the business sector, which examined corporation tax's fiscal impact. Held at ECO's studios, it produced in-depth analysis articles. Moderated by ECO's executive editor Mónica Silvares, the session featured contributions from Sara do

Ó (founder and CEO of Grupo Your) and Pedro Brinca (economist and co-author), fostering a qualified discussion on the tax's economic effects.

Visão Júnior magazine

The Foundation continued its longstanding partnership (since 2016) with the School Libraries Network on the "Kids Get to Vote" reading promotion project. Modelled on an electoral process, Pordata participated in compiling the shortlist of nominated books and tallying results by school cycle.

2024 Financial Report

THE FINANCIAL report presents the Foundation's accounts for 2024.

The payments promised and contracted with the Founding Family were made to the Foundation in accordance with the schedule set out in the contract. reflecting once again their confidence in the Foundation's governing bodies.

The Board of Directors follows a prudent financial policy and maintains existing reserves to ensure we can meet all our commitments.

The Board of Directors has staffed the Foundation appropriately for ongoing projects, as illustrated by the operating and personnel costs in the Report and Accounts.

Thematic and functional allocations across projects demonstrate consistency in our choices and methods.

Under the Board of Directors' resolution of 24 June 2016, any annual net surplus or deficit is transferred to the Endowment Fund under "Retained Earnings." Accordingly, the Board of Directors proposes that the positive net result of €795,682 for 2024 be moved to Retained Earnings. At the end of the year, the Endowment Fund stood at €10,178,801.

Outlook for 2025

DURING 2025, the Foundation will continue to implement its strategy focused on impact and change, internationalisation and institutional development. We plan to strengthen the team in line with the strategic plan, limit unplanned initiatives and refine the criteria for accepting external contributions. Next year's activity plan will privilege two key themes: Pordata's 15th anniversary and, in a year of local elections, an analysis of "the national reality."

Pordata will celebrate its 15th birthday with a portal that is both forwardlooking and accessible to all citizens. In this way, the Foundation will strengthen its mission — to offer free, impartial and rigorous data — by fostering factbased dialogue and informed opinion at a time of growing misinformation. The new portal will serve not only specialists but also the general public, regardless of statistical literacy. Its contribution to democratic quality and its role in educating society are unequivocal.

The "national reality" theme will run until September, ahead of the local elections. We will draw on Pordata's municipal level data, issue press releases and

partner with national and local media to supply them with useful facts. We intend to dedicate one of the three barometers set for publication in 2025 to this theme.

We will lay the groundwork for the Foundation's first impact assessments, examining how our recommendations influence public policy changes. This will allow us to evaluate our contribution to societal development, citizens' rights advocacy and better institutions. The team will establish new evaluation criteria to measure how society values our content, ensuring that we can enhance impact without sacrificing reach.

We will increase the Foundation's international presence through initiatives involving foreign researchers and partner institutions, participation in international events and networks, an English version of the FFMS and Pordata portals, briefings to foreign and EU bodies using official Pordata data, distributing our publications to Portuguese bookstores abroad and translating key publications into other languages.

We will continue building our institutional profile to raise awareness of the Foundation and its projects — especially among younger audiences - via our own initiatives and partnerships with media and other institutions. We will maintain a regular presence at major national events, making our work available to institutions and citizens alike.

Making the best decisions regarding Portugal's future requires promoting democracy, mobilising civil society to tackle the country's main challenges and disseminating rigorous, sciencebased information that equips Portuguese citizens with reliable knowledge. In our 16th year, the Foundation will actively pursue these objectives in fulfilment of its mission.

1. Introductory Note

THE FUNDAÇÃO Francisco Manuel dos Santos, hereinafter referred to as the "FOUNDATION," "FFMS" or the "Entity," is a private legal entity of indefinite duration, non-profit in nature, established by Sociedade Francisco Manuel dos Santos, Holding NV, formerly Sociedade Francisco Manuel dos Santos, SE (Founding Entity), on 12 February 2009, with its registered office at Largo de Monterroio Mascarenhas, no. 1, civil parish of Campolide, Lisbon municipality and district.

The FOUNDATION was formally recognised by Order no. 13591/2009 of 5 June 2009 and declared a legal person of public utility by Order no. 5159/2010 of 12 March 2010, both issued by the Office of the Secretary of State for the Presidency of the Council of Ministers.

On 1 March 2013, confirmation of the FOUNDATION's public utility status was published in the Diário da República, 2nd series — No. 43 — Block C, following which the FOUNDATION has been governed by the Framework Law on Foundations, approved by Law no. 24/2012 of 9 July.

The deed formalising the new statutes, executed on 21 November 2013 and published on the Portuguese Ministry of Justice portal, was approved by the Council of Ministers via official communication no. 3666/DAJD/2013.

The FOUNDATION's primary objective is to promote and deepen knowledge of Portuguese reality, seeking to contribute to the inter--relational development of society, the strengthening of citizens' rights and the improvement of public institutions.

In this context, the FOUNDATION has carried out studies in various social fields, including demography and population, economic and social development, health, education, vocational training, social security, the state and democratic institutions. Details of each of these studies are provided in the "Annual Activity Report."

2. Accounting Framework for the Preparation of the Financial Statements

2.1. Disclosure of the accounting framework used in the preparation of the financial statements

The attached financial statements were prepared in accordance with the Accounting Standardisation System for Non-Profit Sector Entities (SNC-ESNL) approved by Decree-Law no. 36-A/2011 of 9 March, which is part of the Accounting Standardisation System (SNC), approved by Decree-Law no. 158/2009 of 13 July and republished by Decree-Law no. 98/2015 of 2 June, which transposed Directive 2013/34/EU of the European Parliament and of the Council of June 2013 on annual financial statements into Portuguese law. From 1 January 2016 onwards, FFMS has adopted the financial statement models set out in Ministerial Order no. 220/2015 of 24 July, as well as the accounting and financial reporting standards established in Notice no. 8259/2015.

Without prejudice to the application of Accounting and Financial Reporting Standard for Non-Profit Sector Entities (NCRF-ESNL) in all aspects relating to recognition, measurement and disclosure, where this standard does not address specific matters encountered by the Entity in the accounting or financial reporting of transactions or situations, or where such omission is material enough to prevent the objective of presenting information that faithfully and appropriately reflects the financial position as at a given date and performance for the reporting period, the Entity refers, solely for the purpose of filling such gaps and in the order indicated, to: (i) the Accounting and Financial Reporting Standards (NCRF) and Interpretative Standards (NI) of the SNC; (ii) International Accounting Standards (IAS); and (iii) International Financial Reporting Standards (IFRS) and their interpretations (SIC and IFRIC).

The financial statements were prepared based on the following principles:

Going concern

Transactions were recorded on the assumption that the Entity will continue operating for a period of at least twelve months from the reporting date, with no limitation.

Accrual basis of accounting

Items are recognised as assets, liabilities, endowment funds, income, and expenses when they satisfy the definitions and recognition criteria. Income and expenses are recognised as they are earned or incurred, regardless of when the corresponding cash is received or paid.

Consistency of presentation

The presentation and classification criteria for items in the financial statements are maintained from one period to the next, unless (i) it is evident, after a significant change in the nature of operations, that another presentation or classification is more appropriate based on the criteria in the NCRF-ESNL, or (ii) the NCRF-ESNL mandates a change, and in any case, (iii) the new presentation provides more reliable and relevant information, and (iv) the revised structure is expected to be maintained in such a way that comparability is not impaired.

Offsetting

Assets and liabilities, as well as income and expenses, are reported separately in their respective financial statement lines. No asset is offset against a liability, and no expense is offset against income.

Comparability

The accounting policies and measurement criteria applied in preparing the financial statement figures for the reporting period are the same as those used for the comparative figures. When the presentation or classification of financial statement items is revised, comparative figures are reclassified accordingly, unless this is impracticable.

2.2. Indication and justification of any SNC-ESNL provisions that have been exceptionally departed from, and the effects on the financial statements, in view of the need to present a true and fair view of the entity's assets, liabilities and result

No provisions of the SNC-ESNL were exceptionally departed from in preparing these financial statements, as it was not necessary to do so in order to present a true and fair view of the Entity's assets, liabilities and results.

2.3. Identification and commentary on Balance Sheet and income statement items that are not comparable with the previous period

All items in the Balance Sheet and statement of income are comparable to those of the previous period.

3. Basis of Presentation and Main Measurement Criteria

The main measurement criteria used in preparing the financial statements were as follows:

Other financial assets — Treasury funds and investment portfolios are recorded at acquisition cost and revalued at the end of each financial

period based on the quoted price provided by the financial institution. These assets are marked to market and fair value is determined based on those market prices.

Trade and other receivables — Most sales are made under normal credit terms, and the corresponding customer balances do not include interest charged. At the end of each reporting period, accounts receivable and other receivables are reviewed for objective evidence of uncollectibility. If such evidence exists, the corresponding impairment loss is recognised immediately.

Trade and other payables — Liabilities to suppliers or other third parties are recorded at their nominal value, as they do not bear interest and the discount effect is deemed immaterial.

Accruals and deferrals — Differences between amounts received or paid and the corresponding income or expenses are recorded under accruals and deferrals.

Founders' grants — Grants from the Founder are recorded under the Endowment Fund on the date the grant is confirmed.

Operating subsidies — Contributions received from the Founder to cover project and operating expenses are recognised in full as income in the period. This criterion has been adopted since 2016, following a decision by the Executive Committee and the Board of Directors, after the signing of a new Grant Agreement on 11 February 2016 with Sociedade Francisco Manuel dos Santos, SE, for a ten-year period.

Inventories — Goods comprising essays and other publications are measured at the lower of production cost or net realisable value.

Interest and similar income — Interest arises from remunerated financial investments.

Net result for the period — The annual net result, whether positive or negative, is transferred to the endowment fund. under retained earnings. (In periods prior to 2016, the result was always zero due to the income recognition procedure described above.)

The amount payable to Social Security corresponds to the amount due in January of the following year.

In accordance with current legislation, tax returns are subject to review and correction by tax authorities for a period of four years (five years for Social Security). Therefore, the Foundation's tax return for the year 2024 may be subject to review. However, management believes that any adjustments resulting from such reviews or inspections will not have a significant impact on these financial statements.

Opinion

We have audited the accompanying financial statements of de Fundação Francisco Manuel dos Santos (the Entity), which comprise the Balance Sheet as at 31 December 2024 (showing a total of 11.716.109 euros and a total endowment funds of 10.178.801 euros, including a net profit for the year of 795.682 euros), the Income Statement by Nature and the Statement of Cash Flows for the year then ended, and the Annex, including a summary of significant accounting policies.

Charter of Principles

THE FRANCISCO MANUEL DOS SANTOS

FOUNDATION intends to ponder, study and contribute to a better understanding of Portuguese reality. It aims to collaborate in the effort to solve problems faced by society, for the benefit of the Portuguese people and of generations to come.

In order to achieve such a goal, the Foundation shall promote the execution of studies, research works and further initiatives which, by complying with the highest standards of rigor and quality, should enable a better understanding of reality, offer concrete solutions and recommendations to decision-makers, lead to a meaningful debate regarding major national problems and contribute to greater justice, development and to reinforcing social cohesion.

The Foundation's activity shall be guided by the principles of personal dignity and social solidarity and by the values of democracy, freedom, equal opportunities, merit and pluralism.

The Francisco Manuel dos Santos Foundation shall act with absolute independence regarding all powers, public and private, ideologies, currents of opinion, philosophical tendencies, creeds and religious denominations. The Foundation's governing bodies shall act as guarantors of compliance with its bylaws, notably that of its independence.

The Francisco Manuel dos Santos Foundation deems it essential to promote a more active involvement of civil society in reflecting and solving national problems and thus it shall endeavor its best efforts so that citizens are widely aware of its initiatives and projects. In line with this, the Francisco Manuel dos

Santos Foundation shall seek to provide Portuguese society with clear, objective and accurate information concerning the findings of its activities, as well as ensuring the utmost transparency with respect to its organization, its goals, its sources of funding and its activities.

The Foundation believes that holding broad-based, pluralistic and public debates regarding its recommendations is just as important an aim as is carrying out studies and research works.

In its activities, the Foundation shall seek to be faithful in its commitment to social responsibility, which constitutes its mission, as defined by the Founders.



Article 1 (Nature)

THE FRANCISCO MANUEL DOS SANTOS

FOUNDATION, created by the Francisco Manuel dos Santos Society, SGPS, S.A. (Founding Society), is a non-profit legal person ruled by private law, governed by the present bylaws and, in any matter omitted by them, by Portuguese Law.

Article 2 (Object and Purposes)

1. The Foundation's primary purpose is to promote and further the knowledge about the Portuguese reality, thus seeking to contribute to the development of society, the reinforcement of citizens' rights, and the improvement of public institutions.

With this fundamental purpose, and without prejudice to carrying out other activities appropriate to fulfilling its objectives, the Foundation will promote research studies in various areas, conducting analyses about selected subjects, publishing results, formulating recommendations and promoting public debate on the matters about which research work is conducted.

- 2. The areas covered shall be most diverse, with special emphasis on: a) Population and demographics; b) Social and economic conditions of families and people; c) Economic, social and human development; d) National and cultural identity; e) The State, Public Administration, democratic institutions and territorial organization; f) Justice, and the rights and duties of citizens; g) State welfare, Health, Education and Social Security; h) Public policies; i) Civil society, private institutions, associations and businesses.
- **3.** The projects conducted by the Foundation should meet the highest standards of scientific rigor and independent analysis; convey a true diversity of opinions; ensure critical freedom of expression by its authors; prioritize relevant matters for society.
- 4. The Foundation will remain independent from organizations and interests of a political, party, economic, religious and other natures.
- **5.** The Foundation will approve a Charter of Principles and a Code of Good Practice. These documents will be widely divulged and will include norms and rules of conduct which the members of the Governing Bodies will commit to upholding and enforcing.

Article 3 (Exclusions)

The Foundation shall not grant any donations or by any other means promote any activities in respect of health care service provision, charity, sports, artistic creation, cultural expression, education, academic or professional education, and individual scientific research, nor contribute to general and current operation expenditures of any entities or organizations, or to the construction of any buildings, or to the acquisition of equipment and vehicles, to the rental of any premises, to the participation in conferences and seminars, shows, political activities or of political parties, or of any professional associations, nor cooperate in public calls for fund raising, nor for the organization of exhibitions or museums, nor for the preservation of cultural or built heritage.

Article 4 (Duration)

The Foundation's duration is unlimited.

Article 5 (Registered office)

The Foundation's registered office is Largo Monterroio Mascarenhas, nr. 1, 1099-081 Lisbon, Campolide, Lisbon Council.

The Board of Directors may establish branches or other forms of representation wherever is deemed necessary or convenient for the fulfilment of its purpose.

Article 6 (Assets)

- 1. The Foundation's assets consist of:
 - a) An initial own equity of € 1,000,000.00 (one million euros),

- which the Founding Society allocated to it:
- b) Donations since contracted with the Founding Society:
- c) The product, in assets or rights, of any subsidies, donations, inheritances, legacies or free concessions by any entities, public or private, Portuguese or foreign;
- d) All assets, movable or immovable, and rights which the Foundation may otherwise acquire;
- e) Income resulting from managing its assets;
- f) The product of any loans it may contract;
- g) Income generated by the services provided in the development of its activity.
- **2.** For all intents and purposes, the Founding Society expresses its intent to grant the nature of the Foundation's income to the economic benefits referred to in paragraphs b) through to g) of the previous point, as well as any other economic benefits accrued by the Foundation, except for those related to the initial own equity referred to in paragraph a) of the previous point, or any others which may specifically fall under the nature of own equity.

Article 7 (Investments and Contributions)

The Foundation may alienate and encumber assets or rights and enter into obligations, as well as carry out investments, in the terms which the Board of Directors deems appropriate to pursue its objectives or to conduct a more productive or secure application of the value of its assets.

The Foundation may not accept donations, inheritances or legacies

subject to any condition or obligation which goes against its object, purpose and independence.

Article 8 (The Foundation's Governing Bodies)

The Board of Trustees, Supervisory Board, Board of Directors and Executive Committed are all part of the Foundation's Governing Bodies.

Article 9 (Board of Directors)

- 1. The Board of Directors is made up of five to eleven members, always an odd number, one of which will be chairman; the Executive Committee is part of the Board of Directors, as provided in article 11.
- **2.** The members of the Board of Directors serve five-year terms, which may be renewed up to two times.
- **3.** The chairman and remaining members of the Board of Directors are elected by the Board of Trustees, on indication by its chairman.
- 4. If a member of the Board of Directors is also a member of the Board of Trustees his/her term of office in the Board of Trustees will be suspended for the duration of his/her term served in the Board of Directors.
- **5.** All deliberations by the Board of Directors are conducted by majority voting, with the chairman holding the casting vote.

Article 10 (Responsibilities of the Board of Directors)

- 1. The chairman of the Board of Directors. in particular, is responsible for promoting the projects conducive to fulfilling the Foundation's goals.
- 2. The chairman of the Board of Directors is also responsible for proposing to the Board of Trustees, whenever he/she deems appropriate, the adoption and/or change in any of the Foundation's means of internal organization.
- **3.** The Board of Directors is responsible for managing the Foundation's assets, as well as to deliberate on proposals to change its bylaws, alter or extinguish the Foundation and, in particular, for:
 - a) Managing the Foundation's assets, taking any action necessary for that purpose, including the actions provided for in point 1 of article 7;
 - b) Approving the annual activity plans, the financial report, balance sheet and notes accounts, submitting them for the approval of the Board of Trustees:
 - c) Approving the annual budget;
 - d) Implementing and maintaining internal systems for account auditing, in such a way that they reflect, thoroughly and completely at any given moment, the Foundation's assets and financial situation;
 - e) Deliberating on opening new branches or other forms of representation;
 - f) Proceeding to accept donations, sponsorships, co-funding and subsidies allocated to specific projects carried out by the Foundation.

Article 11 (Executive Committee)

- 1. The Executive Committee is part of the Board of Directors and is made up of a chairman and four members. The chairman of the Executive Committee may concurrently be the chairman of the Board of Directors.
- 2. The Executive Committee is elected by the Board of Directors on their first meeting, except if its members have already been expressly appointed by the Board of Trustees over the course of the election for the Boards of Directors.
- **3.** Generally speaking, the Executive Committee is responsible for the day-to--day management of the Foundation, in particular:
 - a) Recruiting, managing and supervising staff;
 - b) Assessing and approving proposals for projects or activities and all pertaining terms and conditions, approving the grant of subsidies, financial support or loans to specific projects and any other of the Foundation's expenses;
 - c) Making any decision and perform any duty which is not expressly allocated to another governing body.
- 4. All deliberations by the Executive Committee are conducted by majority voting, with the chairman holding the casting vote.

Article 12 (Links within the Foundation)

- 1. The Board of Directors represents the Foundation, in or out of court, holding the power to delegate to any of the members of the Board of Directors.
- **2.** The Foundation is bound by the joint signature of two members of the Board of Directors, one of which must also be a member of the Executive Committee.
- 3. Both the Board of Directors and the **Executive Committee may appoint** authorized representatives, delegating responsibility onto them, in which case the Foundation may be requested a joint signature from a member of the Board of Directors and a representative in the terms established in the mandate.

Article 13 (Board of Trustees)

- 1. The Board of Trustees is made up of five to nine members, appointed among figures of renowned merit and proven moral integrity, and with expertise in the fields appropriate to carrying out the Foundation's activities.
- 2. The chairman of the Board of Trustees is appointed by the Founding Society, while the latter holds legal existence. If the Founding Society does not hold legal existence at the time of appointment, then the chairman will be elected by a majority of votes from the members of the Board of Trustees itself.
- 3. The remaining members of the Board of Trustees are appointed by deliberation from the Board itself, by proposal by the chairman of the Board of Trustees.
- 4. The members of the Board of Trustees serve five-year terms, which may be renewed once for the same period.

- However, the terms of office served by any of the members may be renewed beyond a second term by proposal from the chairman of the Board of Trustees and deliberation by a two-third majority of votes cast by its members.
- 5. The term limit provided for under the previous point does not apply to the chairman of the Board of Trustees.
- **6.** The term of office of members of the Board of Trustees will cease under the following circumstances:
 - a) Completion of term of office, as detailed under point 4;
 - b) In case of death or permanent disability;
 - c) Resignation sent by letter to the chairman of the Board of Trustees:
 - d) In case of deliberate exclusion under secret ballot by a two-third majority of votes cast by the incumbent members of the Board, based on indignity, serious misconduct or manifest lack of interest in performing his/her duties.
- 7. The Board of Trustees will meet at least once every semester and extraordinarily whenever summoned by the chairman, either by his/her initiative or at the request of the chairman of the Board of Directors, or of the majority of members of the Board of Trustees.
- 8. The members of the Board of Trustees may be represented by another member at the meetings, by means of a written communication previously addressed to the chairman, with the exception of the votes referred to under article 16.
- **9.** The duties performed by the members of the Board of Trustees are not remunerated. However, they are granted attendance subsidies and travel and per diem allowances.
- 10. With the exception of otherwise specified directives, the deliberations by the Board of Trustees are decided by majority

- voting, with the chairman holding the casting vote.
- 11. Members of the Board of Directors and/or the Executive Committee may take part in the meetings of the Board of Trustees, upon invitation by the chairman, without voting rights.

Article 14 (Responsibilities of the Board of Trustees)

- 1. The Board of Trustees is responsible for:
 - a) Ensuring the upholding of the Foundation's guiding principles and approving the general directives of its functioning and pursual of goals;
 - b) Appointing, under the terms of article 9, point 3, the members of the Board of Directors:
 - c) Dismissing members of the Board of Directors:
 - d) Deliberating on the proposals by the chairman of the Board of Directors, submitted under the terms of article 10, point 2, as to the adoption and/or change in any of the Foundation's means of internal organization, by adopting internal regulations, resolutions or any other method deemed appropriate;
 - e) Appointing its own members, under the terms of article 13;
 - f) Assessing and approving the financial report, balance sheet and accounts, submitted by Board of Directors:
 - g) Appointing the Supervisory Body, under the terms of article 15;
 - h) Defining the remuneration status of the members of the administration and supervisory bodies, as well as the value of the subsidies and per

- diem allowances granted to its own members, by a committee made up of three members of the Board of Trustees, one of which being the chairman:
- i) Approving the acceptance of donations, subsidies, inheritances or legacies by any entity, other than the cases provided for under article 11, point 3, paragraph c), whether or not they imply the Foundation incurring expenses or establishing conditions.
- **2.** The committee referred to under paragraph h) of the previous point is elected by the Board of Trustees, by proposal from the chairman, who also presides over the voting, and deliberates on it.

Article 15 (Supervising)

- 1. The Foundation is supervised by an Supervisory Board made up of a chairman and two members.
- **2.** The supervisory body is appointed by the Board of Trustees, by proposal from the chairman, and the terms of office have a five-year duration.
- **3.** The supervisory body is responsible for:
 - a) Annually examining and issuing an opinion on the balance sheet and notes accounts to be approved by the Board of Directors and the Board of Trustees:
 - b) Periodically checking the good standing of the Foundation's bookkeeping;
 - c) Quarterly examining and issuing an opinion on the accounts presented by the Executive Committee.

Article 16 (Changes in Bylaws, Transformation and Extinction)

- 1. Changes in the present Bylaws and the transformation and extinction of the Foundation may only be decided upon proposal by the chairman of the Board of Trustees, by means of approval in a joint meeting between the Board of Directors and the Board of Trustees, a decision made under the following terms, without prejudice of the legal provisions in force on the matter:
 - a) The proposal will need to gather favorable votes from the majority of incumbent members of each of these Boards, considered individually; and without prejudice of the previous paragraph a), the proposal will also have to gather favorable votes from two thirds of the total number of incumbent members of said Boards, considered jointly;
 - b) In case of extinction, the Foundation's assets will be allocated to whichever destination is deemed, by joint decision from the bodies referred to under the previous point, more appropriate for pursuing the purpose for which it was created, without prejudice of the applicable legal provisions pertaining to the destination of assets in case of extinction.

Article 17 (Founding Society's Intent)

The present bylaws wholly reflect the intent of the Founding Society, and whichever questions arise pertaining to their interpretation or application shall be resolved by the Founding Society or, in the event that it does not hold legal existence, by the Board of Trustees.



I – Declaration of principles

THE FOUNDATION Francisco Manuel dos Santos (hereinafter "FFMS") was incorporated on February 12, 2009 and is a non-profit organization whose major mission is to promote and to strengthen the understanding of Portuguese reality, thus seeking to contribute to the development of society, the reinforcement of citizens' rights and to the improvement of public institutions. The Foundation believes that by increasing thinking and studying about the Portuguese national reality, it might decisively contribute to a better understanding of this reality, and thus towards solving its problems, for the benefit of all Portuguese people in this generation and for generations to come.

In order to achieve such targets and notwithstanding the fact that FFMS shall carry out other initiatives that are adequate to meet its goals - FFMS is, and shall continue to be, committed to promoting the production of studies, research work and other projects in the most diverse fields, which shall ensure the highest standards of scientific rigor, quality, and independent analysis, and whose scope shall allow the achievement of a comprehensive and meaningful analysis of relevant issues in our society, by presenting specific solutions and recommendations for deciding authorities, by building a debate about major Portuguese problems and thus contributing towards justice, development and the reinforcement of social cohesion.

It is a mandatory principle from which there can be no derogation that such works, studies and projects shall translate into a real plurality of opinions and shall ensure the authors are free in expressing their opinions and criticisms. Furthermore, the Foundation hopes to improve the understanding of Portuguese reality predominantly by civil society, whose active involvement in reflecting and solving national problems FFMS deems as essential.

Moreover, precisely with the goal of promoting a more active involvement of such civil society in mind, FFMS shall endeavor its best efforts so that citizens are widely aware of its projects and initiatives. In line with this, the Francisco Manuel dos Santos Foundation shall seek to provide Portuguese society with clear, objective and accurate information concerning the findings of its activities, as well as ensuring the utmost transparency with respect to its organization, aims, funding sources and activities. In addition, the Foundation shall promote broad-based, pluralistic and public debates regarding its recommendations, given its belief that holding

such debates is just as important an aim as carrying out the studies and research work mentioned above.

The areas on which the Francisco Manuel dos Santos Foundation intends to focus its activities are quite diverse. However, special emphasis should be given to actions where FFMS's action tends to be more relevant, which concern the following subjects: demography and population, social and economic conditions, economic and social development, health, education, professional training, Social Security, the State, national identity, Public Administration, rights and duties of citizens, citizenship and democratic institutions, labor relations, organization of the Portuguese territory, towns, the social issue, inequalities and conflicts, justice, economic and social policies, public institutions, major public service, relationship between State and citizens, access to culture, information and the media.

The Foundation's activity shall be guided by the principles of personal dignity and social solidarity and by the values of democracy, freedom, equal opportunities, merit and pluralism.

The Francisco Manuel dos Santos Foundation shall act with absolute independence regarding all powers, public and private, ideologies, currents of opinion, philosophical tendencies, creeds and religious denominations. The Foundation's governing bodies shall act as guarantors of compliance with its bylaws, notably that of its independence.

In its activities, the Foundation shall seek to be faithful in its commitment to social responsibility, which constitutes its mission, as defined by the Founding Society.

II — Code of Good **Practices**

Introduction and General Principles

The Francisco Manuel dos Santos Foundation, hereinafter "Foundation" or "FFMS", is guided by its Bylaws, Charter of Principles and this Code of Good Practice. The Foundation is guided:

- a) by the principle of transparency of norms and procedures, regulations and regulatory provisions, and the minutes of the meetings between its governing bodies shall reproduce fully and faithfully everything that has taken place within them;
- b) by the democratic principle, whereby the decisions made by its governing bodies are reached by voting majority and equality, with a casting vote in specifically provided cases;
- c) by the principle of institutional loyalty, whereby all members of FFMS's governing bodies and staff members abide by the Foundation's principles and mission, as well as its regulations and norms, and deliberations taken by the governing bodies. In addition, they shall act according to principles of good faith, diligence, responsibility, zeal and care, as well as by high ethical standards of integrity and loyalty, in accordance with the principles of ethics and professional conduct listed in the present Code of Good Practice;
- d) by the principles of truth and legality, whereby the Foundation makes a commitment that all information it imparts is current, objective, true, clear and comprehensive, abiding by the applicable legal, regulatory and contractual provisions.

Scope of application

Unless otherwise specified, the Foundation's Code of Good Practice is applicable to all members of FFMS's governing bodies and staff members, while also serving as a model for the public in terms of ethical and conduct standards required by the Foundation.

Functional principles and rules

Relationship with the public

The conduct of all members of FFMS's governing bodies and staff members must abide by practices that are honest, transparent, clear, professional and diligent, in order to develop ties of trust and credibility, thus contributing to the Institution's success and reliability.

Relationship with external entities

Any contacts, formal and informal, with representatives of other institutions, public and private, Portuguese or foreign, shall at all times reflect the Foundation's guidelines and standings, and all members of FFMS's governing bodies and staff members must conduct these relationships according to standards of quality, integrity, courteousness and transparency.

Selecting and recruiting staff members and suppliers

The Foundation recruits its staff members and suppliers through a process of objective and transparent assessment, using criteria based on their merit, the conditions for service provision and supply, assured quality in the goods and services provided and in accordance with the best environmental practices.

Mission

All staff members are indispensable to the pursuit of the mission and statutory purposes of the Foundation. These should be developed in a sustainable manner and founded upon the establishment of a culture based on values of trust, mutual respect, responsibility and goal development, as well as work discipline.

Working environment and corporate culture

The Foundation holds, as priority goals, the creation and maintenance of a corporate and social environment defined by wellbeing which encourages the professional and personal development of each individual, as well as recognizing and rewarding effort and individual and collective contributions to pursuing its mission.

Social action

The Foundation is committed to the development of a policy of social action which is effective and defined by social integration, with a view to respond to the needs of staff members, for the purpose of improving their wellbeing and quality of life.

Prohibition of discrimination

In their actions, no member of FFMS's Governing Bodies or staff member may practice any action which involve any type of discrimination or harassment, namely based on personal or family connections, race, gender, age, sexual orientation, physical ability, ideological, religious or other convictions.

Prohibition of offensive behavior

The members of FFMS's Governing Bodies and staff members must also abstain from using improper or inappropriate language, as well as any other form of behavior which may, by action or omission, be deemed offensive by staff members or substantiate any pressure which may reasonably be deemed abusive.

Personal data protection

- 1 The Foundation is committed to protecting any personal data which, by its nature and specific activity, it may have access to and/or which may be under its custody, being under the obligation of fulfilling its duty of confidentiality. In this way, the governing bodies and staff members may not, in any way, divulge, transmit or use personal data and/or confidential information, except within the regular scope of fulfilling their duties and/or in compliance with the law or by final court decision.
- **2** Under the exceptions provided for in the previous paragraph, the Foundation's governing bodies and staff members will conduct themselves strictly according to legal norms and best practices in matters related to the treatment of personal data and confidential information protection.

Workplace hygiene, health and safety

The Foundation's staff members must abide by the orders and instructions issued by their superiors in matters of workplace hygiene, health and safety, including abstaining from the consumption of alcohol or illegal substances in the performance of their duties.

Environmental protection

The members of the Foundation's Governing Bodies and staff members should adopt the best practices for environmental protection, namely by promoting eco-efficient management, in order to minimize the environmental impact of activities and a responsible use of the Foundation's resources.

Duty of care and technical and professional rigor

The Foundation's staff members must carry out their duties with maximum zeal and technical and professional rigor, thus promoting a continuous improvement of the standards of quality of the service provided by the Foundation. In particular, they are expected to:

- a) Know and act according to the norms and instructions applicable to the performance of their duties;
- b) Continuously strive to perfect and improve their knowledge.

Duty of informing and reporting

Whenever possible, and in accordance with reasonable and prudent criteria, the members of the Foundation's Governing Bodies and staff members must report any actions that are non-compliant with the law and the present Code, namely abusive pressure or harassment, that they are made aware of, and they may not be punished or impaired by such report.

Duty of functional information

- 1 As well as the appropriate performance of the duties that they have been tasked with, the Foundation's staff members must act in a transparent manner, keeping their superiors and other staff members involved in the same processes informed about their work.
- 2 It is contrary to the duty of institutional loyalty to omit facts or any information which might affect the reputation, integrity or quality of the services provided by the Foundation, which must always be reported in accordance with criteria of prudence and reasonability, and using the appropriate hierarchical channels.

Functional reserve and duty of professional confidentiality

1 — The members of the Foundation's governing bodies and staff members cannot divulge or pass on information acquired while performing their duties to people outside the Foundation or any other staff

members who do not require it for performing their duties.

2 — The members of the Foundation's governing bodies and staff members are also forbidden from using any information they obtain access to while performing their duties to promote their own interests or those of third parties.

The Foundation's resources

- 1 Each of the members of the Foundation's governing bodies and staff members is responsible for the appropriate use and protection of the Foundation's assets and resources, thus being obliged to use those assets and resources for their respective social purpose and to protect them against fraud, theft, alteration or loss which might result from their own actions or those of third parties, ensuring its preservation and adequate use.
- 2 The governing bodies and, in particular, those in charge of managing the Foundation's resources are responsible for adopting procedures and a conduct which ensures prudence and a parsimonious use of the available resources, avoiding waste and preventing excessive expenses and costs that are incompatible with the Foundation's profile and mission.
- **3** The members of the Foundation's governing bodies and staff members must respect and protect the Foundation's assets. The Foundation's resources must be used efficiently, for the purpose of pursuing established goals and not for personal purposes. Therefore, all staff members must care for their protection and good working order, and prevent third parties from abusive use of the Foundation's services, equipment and facilities.
- **4** The members of the Foundation's governing bodies and staff members must also, in performing their roles, adopt all

appropriate and justified measures in order to limit the Foundation's costs and expenses, so as to enable a more efficient use of the available resources.

Prohibition of perceived gifts or other benefits

- **1** In accordance with the principles of transparency, impartiality and independence, the members of the Foundation's governing bodies and staff members are prevented from receiving any gifts, payments or other benefits from clients, suppliers and/or beneficiaries who are in any way connected with their role within the Foundation.
- **2** In these terms, it is stated as a rule to deliberately decline any gifts for which the market value exceeds € 150.00.

Corruption

The members of the Foundation's governing bodies and staff members must actively oppose all forms of corruption, either active or passive, paying particular attention to any form of payments, favors and complicities which might enable the creation of unlawful advantages, such as gifts or offers by suppliers or other entities.

Conflicts of interest

1 — Conflict of Interest, actual or potential, means any situation in which members of the Foundation's Governing Bodies and permanent staff members have a personal or private interest, direct or indirect, in any matter that could influence, or apparently have an influence, directly or indirectly, on the impartial and objective performance of their professional obligations, or which may in any way enter, potentially or effectively, into conflict with the Foundation's interests for a particular deliberation, as well as any circumstances related to said member of the Foundation's

- Governing Bodies or staff member or a third party susceptible to impairing his/ her impartiality in any way in that context.
- **2** Personal or private interest means any possible advantages for the individual, his/her family or equivalent, his/her circle of friends, another member of the Foundation's governing bodies or permanent staff member, or for a company or institution in which he/she holds interests or is a part of.
- **3** Any potential conflicts of interest must be immediately reported, depending on the case, to the immediate superior, the chairman of the Board of Directors or the chairman of the Board of Trustees.
- 4 -If the immediate superior, the chairman of the Board of Directors or the chairman of the Board of Trustees concludes that there is a conflict of interests. after analyzing the situation reported by the staff member, he/she shall exclude him/her from any discussion and/or voting in the deliberations under discussion or those in any way related.
- **5** The minutes of the meetings of the Foundation's governing bodies must reproduce any situation of conflict of interest recognized by the respective members.
- **6** The members of the governing bodies shall address, depending on the case, to the chairman Board of Directors or the chairman of the Board of Trustees, in the 30 days after the present Code comes into force, a list of the institutions or companies of which they are members or in which they perform any role, as well as updating it whenever any changes occur. **7** — A Register of Interests will be created via Regulation, which will be made available on the Foundation's official webpage.

Exclusivity

- 1 Any professional activities external to the Foundation, paid or unpaid, performed by employees or members of the Executive Committee must always be previously authorized by the Board of Directors.
- **2** Employees or members of the Executive Committee may perform research or academic activities. They may engage in teaching or research, speak at conferences, write books or essays of a technical-scientific nature or develop other activities of the same nature, even when the subject matter is related to the scope of his/her professional role, as well as performing non-executive duties in other institutions.
- **3** The performance of an external professional activity which substantially reduces the time available by the employee or member of the Executive Committee to perform his/her duties should necessarily be reflected in his/her wages.
- 4 Employee or members of the Foundation's Executive Committee should inform the chairman of the Board of Directors about any role they perform, paid or unpaid, in other institutions.

Incompatibilities

- 1 The following roles or duties are deemed incompatible with the performance of duties as employees or members of the Foundation's Executive Committee:
 - a) Holder or member of any organ of
 - b) Executive or consulting roles in other foundations.
- 2 The Board of Directors will deliberate on a case-by-case basis as to the performance of duties in public or private companies by members of the Executive Committee

Political activities

- 1 While performing civic or political activities, the members of the Foundation's Governing Bodies and staff members must preserve the Foundation's independence and not compromise their capacity and ability to pursue their duties in accordance with the terms of the respective bylaws.
- 2 Members of the Executive Committee, coordinators and area consultants may not integrate any political management or national executive bodies, nor act as spokespersons for political parties.

Final provisions

Dissemination

- 1 The Foundation's Code of Good Practice is public and should be disseminated and made available to all staff members in online digital format, and it provides for the possibility, through a continuous and participatory process, of being updated and adapted.
- 2 The Foundation must adopt efficient measures to inform the public about the present Code, namely by making it available on its official website.
- 3 The recruitment process for new Foundation staff members must include a confirmation of knowledge and acceptance of the present Code.

Sanctions

The violation of any norm or principle implied or inherent in the present Code of Good Practice may entail disciplinary action taken against the defaulter.

Questions and omissions

1 — To clarify any questions arising about the matters addressed in the present Code, to communicate any irregularity or to resolve potential issues, a Trustee will

be nominated as particularly responsible for the enforcement of the present Code. Any request for clarification, complaint or any other matters which the members of the Foundation's governing bodies and staff members deem appropriate to submit to the Board of Directors or the Board of Trustees should be addressed to said Trustee.

2 — For any situation which is omitted in the present Code, the Board of Directors or the Board of Trustees, depending on the case, will be responsible for deliberating in accordance with the Foundation's Charter of Principles.

Entry into force

The present Code comes into force on the date it is communicated to all of the Foundation's staff members and services. and compels, without exception, all of those who are included in its scope such as it has been defined, and it is not legitimate for them to claim lack of knowledge and/or unclarity as a reason for exemption of guilt and/or responsibility.

Alterations, modifications or replacements

The present Code may only be altered, modified or replaced, either fully or partially, by joint deliberation from the Foundation's Board of Trustees and Board of Directors.

It promotes and extends knowledge of contemporary Portugal, thus contributing to the development of society, the consolidation of citizens' rights and the improvement of public institutions. These goals are pursued through the studies carried out on selected themes, the publication of research findings on the Pordata website, the issuing of recommendations, and the encouragement of public debate on the matters under study, especially in the areas of demography and population, social and economic conditions, social and economic development, health, education, professional training, social security, State, national identity, public administration, citizens' rights and duties, citizenship and democratic institutions, work relations, spatial planning, urban issues, social problems, social cohesion, inequality and conflict, justice, economic and social policies, public institutions, main public services, relationship between State and citizens, access to culture, information and the media.



Procedures for Assessment of the Foundation's **Activities**

- 1. The assessment of activities will be conducted according to good governance principles, in accordance with number 5 of Article 2 of the Statutes, namely the adequacy the Foundation's aims and purposes; conformity with Statutes, Plans and Budgets; scientific, political and economic exemption and independence; social, political or cultural relevance; seriousness and frugality; and accountability.
- **2.** The assessment of the Foundation's activities aims to assist the Board of Directors and the Board of Directors Executive Committee in the fulfilment of their duties, in accordance with the Statutes and Internal Regulations, namely in decision-making on the maintenance, development or ceasing of ongoing activities and publications.
- 3. Under no circumstance does the assessment of the Foundation's activities inhibit the power of decision-making of the Board of Directors and Board of Directors Executive Committee, in accordance with the Statutes and Internal Regulations.
- 4. Assessments may be internal and external.
- 5. Internal assessments will be periodic and based on the principles of internal responsibility and accountability.
- 6. External assessments will be occasional and based on the principles of transparency, external consultation, exemption, independence and exogamy.
- 7. The assessment of the Foundation's activities as an element of consultation

- and support of the decision will be the responsibility of the Executive Committee, except when it involves an amount above one hundred thousand. in accordance with Internal Regulations.
- 8. The Executive Committee will previously inform the Board of Directors of all of the assessments it wishes to conduct. as well as their progress, including the following formal elements:
 - a) Type of assessment;
 - b) The purpose of the assessment;
 - c) The advisors' names;
 - d) The reference terms for the assessment:
 - e) The assessment's schedule;
 - f) The assessment's methodology.
- **9.** The Executive Committee will inform the Board of Directors of all assessments conducted and concluded. The corresponding results and final reports will be supplied to any member of the Board of Directors who may request them.
- 10. In accordance with the Statutes and Internal Regulations, the Board of Directors may request from the Executive Committee an internal or external assessment, with the specific aim of assisting the Board of Directors in its duties.
